

Articulation Agreement Between

**Canisius College
(Richard J. Wehle School of Business)**

and

Miami-Dade Community College

April 1, 1996

Canisius College, Buffalo, New York and Miami-Dade Community College (M-DCC) hereby enter into the following articulation agreement governing the matriculation at Canisius College in the Richard J. Wehle School of Business of Associate of Arts graduates from M-DCC beginning in the fall term of 1995 and continuing for a period of four years, after which both institutions will undertake renegotiations of the agreement.

For Miami-Dade Community College A.A. graduates admitted to Canisius College during the period of this agreement, Canisius College will:

- 1. accept the students as having junior standing, with the understanding that some students may need to complete pre-requisite work for the programs in which they enroll. All courses must be completed with a "C" grade or higher.**
- 2. accept the 36 required general education credits earned at M-DCC, including those within the interdisciplinary core curriculum, applying them toward the equivalent lower division, general education requirements of the College.**
- 3. accept the following specified courses as electives: ACG 2001 Principles of Accounting 1, ACG 2011 Principles of Accounting 2, ACG 2071 Managerial Accounting, ECO 2013 Principles of Economics (macro), ECO 2023 Principles of Economics (Micro), MAC 2311 Calculus 1, MAC 2312 Calculus 2, STA 2014 Statistical Methods, and AMH 2010 History of the United States to 1877.**

During the period of this agreement, Miami-Dade Community College will:

1. publicize the agreement among its students and faculty;
2. make available to students through the M-DCC College catalog a description of the recommended A.A. curricula for all **Canisius College** business majors;
3. review the performance of the M-DCC graduates who matriculate at **Canisius College (Richard J. Wehle School of Business)** in each of the academic programs, assessing the student's academic preparation and the success of the general education core courses.

During the period of this agreement, both institutions agree to:

1. monitor the academic performance of students enrolling under the agreement, identify problems, and work cooperatively to adjust details of course sequence and content so that students can transfer with no academic disruptions;
2. arrange articulation meetings to develop major course equivalencies between **Canisius College** and M-DCC;
3. notify each other concerning any contemplated curricular changes which would affect the future of this agreement.
