# ARTICULATION AGREEMENT Between MIAMI-DADE COMMUNITY COLLEGE AND DREXEL UNIVERSITY

Miami-Dade Community College and Drexel University enter into this agreement in order to facilitate the admission of students into the Business, Engineering, Information Systems, Allied Health and Nursing Coop programs at Drexel University.

This agreement facilitates admission to Drexel, with third year status and equal standing with other Drexel students, to Miami-Dade Community College graduates earning the appropriate Associate degree under the conditions specified below. A full-time student thus admitted will be able to complete the requirements for the bachelor's degree at Drexel within eleven quarters (assuming that no remedial or repeated courses are needed and all applicable Drexel grade and other requirements are met).

Students who complete the Miami-Dade Community College courses specified in the "required course equivalencies" section of this agreement are guaranteed the transfer credit for courses indicated in that section. That section also indicates that they will have met the majority of Drexel's core curriculum requirements as well as some of the requirements of their degree program. Courses not listed there, but brought into Drexel on transfer by a student covered by this agreement, will be granted credit according to standard Drexel-Miami-Dade Community College equivalencies and applied to Drexel requirements, if possible, in accord with the intention of this agreement.

This agreement does not cover students who transfer from Miami-Dade Community College without earning the Associate degree.

#### JOINT RESPONSIBILITIES FOR MAINTENANCE OF THIS AGREEMENT

Each institution will maintain and distribute information about the current form of this agreement, and any changes relevant to it, to students, counselors, and faculty advisors.

Drexel University will keep appropriate Drexel offices and staff (including the Provost's office and Admissions office) informed of this agreement and any modifications thereto, and will be responsible for distributing information concerning any changes.

Both institutions will encourage Miami-Dade Community College students to meet with representatives of Drexel University to discuss issues related to admissions and financial aid well in advance of their expected date of entry.

Faculty from each institution teaching in the curriculum for which this agreement has been developed will be encouraged to meet to discuss issues of curriculum and student development.

### REVISION, RENEWAL AND TERMINATION OF THIS AGREEMENT

Drexel University and Miami-Dade Community College are responsible for identifying, and communicating to each other, changes in their respective courses, requirements, or policies that affect this agreement.

This agreement will be in effect as of January 1, 2002 and will be reviewed every three years by Drexel University and Miami-Dade Community College, and will automatically be renewed until superseded by a new agreement or formally terminated. Revisions in the course equivalency lists may be made with the verbal consent of the representatives of the two schools; major revisions to this agreement require their signatures. Either institution may terminate this agreement at any time by written notice at least one year in advance of the effective date of termination. Should this agreement be terminated, it is understood that the termination will not apply to students already accepted to Drexel University under the terms of this agreement, but not yet enrolled in classes at Drexel.

Miami-Dade Community College and Drexel University understand that they shall act in an independent capacity in the performance of this agreement, and shall not be considered as employees, agents, affiliates, or subsidiaries of each other. Neither department has the right to bind or obligate one another in any manner inconsistent with or unrelated to this agreement. This agreement is governed by the laws of the Commonwealth of Pennsylvania.

#### TERMS AND CONDITIONS OF ADMISSION TO DREXEL

- The Miami-Dade Community College Associate degree must be completed with a minimum cumulative GPA of 2.75
- 2. Drexel University requires all of its students to complete courses required for the core or a major with a grade of "C" or higher. Consequently, Miami-Dade Community College courses equivalent to Drexel core of major courses, taken under the terms of this agreement, will receive transfer credit at Drexel only if completed with a grade of "C" or higher.
- 3. The Miami-Dade Community College student must meet all applicable Drexel requirements and deadlines pertaining to application for admission, payments, and placement testing.

# **ARTICULATION AGREEMENT**

# MIAMI-DADE COMMUNITY COLLEGE AND DREXEL UNIVERSITY

Drexel University assures the acceptance of any Miami-Dade Community College second year student who has earned a grade point average of 2.75 or higher (on a 4.0 scale), with the exception of students interested in Drexel's College of Media Arts and Design. Students interested in the College of Media Arts and Design will be reviewed on a case by case basis, and acceptance will be issued if space and the academic profile of applicants permits.

Applicants must apply prior to March 1 of their anticipated year of entry to Drexel

3. Applicants must successfully complete all Miami-Dade Community College graduation requirements from their program of study.

- 4. A maximum of ten applicants with a 3.5 g.p.a. or higher will be eligible for a DU/MDCC scholarship in amounts up to \$8,000 per year.
- The Drexel University catalog contains all information pertaining to degree requirements. Students transfer credits will be evaluated upon acceptance, or evaluated depending on program, by a Miami-Dade Community College/Drexel University articulation agreement.
- 6. This agreement will be reviewed every three years. Any curriculum changes on the part of Miami-Dade Community College and/or Drexel University would necessitate review at an earlier date.

## TRANSFER AGREEMENT BETWEEN

# MIAMI-DADE COMMUNITY COLLEGE ("MDCC") AND PHILADELPHIA HEALTH & EDUCATION CORPORATION, MCP HAHNEMANN UNIVERSITY ("MCPHU")

## **Purpose**

The two institutions, MDCC and MCPHU, enter this Agreement in order to facilitate the transfer of students from MDCC to the College of Nursing and Health Professions of MCPHU for the purpose of entering MCPHU's programs in Addictions Counseling Sciences, Behavioral Counseling Sciences, Biomedical Sciences, Cardiovascular Perfusion Technology, Emergency Medical Services, and Health Sciences and General Studies.

#### II. Eligibility for Admission

#### 1. Application and Credentials

A student wishing to apply for such a transfer (hereafter referred to as the "Candidate") shall submit a complete application for admission, which will include, without limitation, a completed application form and a certified MDCC transcript, and such other information or documentation as MCPHU may reasonably require. See attached exhibits for other Program specific requirements. MCPHU will waive any application free for admission to facilitate Candidate enrollment in the program.

#### 2. Minimum Admission Requirements

In order to be eligible for admission to MCPHU, the Candidate must:

- A. Have completed and been awarded their Associate of Arts or Associate of Science at MDCC;
- B. Achieved a cumulative grade point average at MDCC of 2.5 or better; and
- C. Satisfy all other MCPHU and Program admission requirements in place at the time of application and acceptance into the Program; and

#### 3. Application Date

It is suggested that the completed application be forwarded as soon as reasonably possible to permit a preliminary review of credentials and to assure the Candidate of early consideration. Applications for the Program must be postmarked no later than the Program deadline.

#### 4. Final Decision

Students successfully meeting the criteria for admissions outlined in this agreement will be admitted to the semester requested, if a seat is available, to MCP Hahnemann University.

#### III. Maintenance

- 1. MDCC will serve as the primary contact for students who plan to transfer to the Program. MDCC will assist those MDCC students who intend to apply to MCPHU, and at the time of application, assist the applicant in gathering all necessary credentials and in mailing the completed packet to the MCPHU Office of Enrollment Management.
- 2. Both MDCC and MCPHU will assure that appropriate personnel in their respective colleges are made aware of the existence of the Agreement and are encouraged to support it. At a minimum, admissions staff, career planning and officers, and program directors will be informed of the Agreement.
- 3. Personnel from MCPHU will visit MDCC at least once a year to meet with appropriate faculty and administrators. Meetings with students will also be arranged by MDCC in consultation with MCPHU, including meetings with potential Candidates who intend to transfer to MCPHU as well as with other students who simply may wish to seek general information.
- 4. The faculty, staff, students, and administration of MDCC are encouraged to visit the campus of MCPHU.
- 5. MCPHU will, at its own expense, supply MDCC with appropriate literature created by MCPHU prior to distribution.
- 6. Any changes in curriculum or application requirements will be communicated to MDCC in a timely manner.

#### IV. Evaluation

To serve as a basis for evaluating the Program, MCPHU will gather statistical information regarding applications, applicant credentials, admissions decisions, and performance of those who matriculate at MCPHU from CCC and share this data with the CCC within the limitations of the Family Educational Rights and Privacy Act and any other applicable law.

#### V. Length of Agreement

This Agreement shall begin on February 21, 2002 and continue until terminated. This Agreement can be terminated on June 30th of any calendar year by either institution providing written notice to the other at least one year in advance.

### VI. Miscellaneous Terms

- 1. Both parties agree that in the performance of this Agreement, there will be no discrimination against any student or applicant on account of race, color, sex, sexual preference, disability, religious creed, ancestry, age, national origin, or disabled or Vietnam era veteran status. Receipt by either party of evidence of such discrimination shall be cause for immediate termination of this Agreement.
- 2. This Agreement shall be construed and enforced in accordance with the laws of the

Commonwealth of Pennsylvania.

- 3. This Agreement may be revised or modified by a written amendment signed by authorized representatives of both parties. This Agreement and its exhibit(s) represent the entire understanding of the parties with respect to the subject matter covered herein and supersedes and nullifies any previous agreements between the parties.
- This Agreement and its exhibit(s) shall be binding on the parties and their respective successors and assigns. Neither party shall assign its duties and obligations under this Agreement without the prior written consent of the other party.
- This Agreement is not intended to conflict with or affect any existing or future affiliations 6. between the parties and institutions not a party to this Agreement.

IN WITNESS WHEREOF, the parties, intending to be legally bound, cause this Agreement to be executed by their duly authorized representatives, as of the day and year above first written.
